Leland Park: An Almost Cinderella Story

Leland Park is an almost Cinderella story. After steep budget cuts forced the closure of the recreation center, Leland Park, much loved by the surrounding neighbors, fell into a sharp decline. But thanks to the activism of community members and the support of Los Angeles Recreation and Parks Department, Councilman Joe Buscaino's office, Los Angeles Police Department Harbor Division, and Los Angeles Dodgers, Leland has begun a long-awaited transformation.

Leland Park is a hidden gem, covering nearly 21 acres. Flanking both sides of Gaffey Street as it descends towards the entrance to the 47 Freeway, Leland's main entrance is off of North Herbert Street, tucked at the end of and only accessible via North Meyler Street. Its location, however, coupled with the park's closure, led to an increase in unwanted activity, including graffiti and homeless encampment. Fortunately, Leland's closest neighbors, including Debbie Rouser and Lu Clayton, refused to give up on their neighborhood treasure.

Neighbors diligently called LARAP to report graffiti. Some sent letters of complaint to local papers and politicians. But it took Clayton's shocking emailed video and Rouser's poignant photography depicting the general plight of Leland Park presented at the August 13, 2013 Central San Pedro Neighborhood Council meeting to really get things moving in the right direction. Nancy Lauer, then LAPD Harbor Division Captain, promised her full support to the Leland initiative, including increased patrols and collaboration with the neighborhood group.

Juan Benitez, head of maintenance for LARAP Harbor Area, acknowledged neighbors' concerns and promised to do all that he could. Soon thereafter, Michael Shull, assistant general manager of LARAP, personally took on Leland Park's restoration, meeting with the newly-formed Neighborhood Watch group at Leland's recreation building to brainstorm ideas and air concerns. One of those ideas was to enlist the Dodgers' help in restoring the ball field.

The result of this collaboration has been remarkable. Working together, Joe Buscaino's office and LARAP were able to earmark money for Leland's capital improvements. In addition, LARAP successfully courted the Dodgers and secured funds to refurbish the ball field. And, with great fanfare from neighbors, playground equipment was modified, the recreation building secured, cameras and lights added, trees were removed and/or trimmed, and graffiti was removed promptly.

With groundbreaking on May 19 and the majority of the project funded, the park advisory board is moving forward to work with the city and various non profits like the LA Conservation Corps and Los Angeles Neighborhood Initiative (LANI) to write grants for Leland Park. LARAP is providing a part time maintenance person for trash pick up and light maintenance. Leland's neighbors are positive. And the newly-formed Leland Park Advisory Board, with Debbie Rouser as president, continues to work with LARAP on a monthly bear.

Now, all that Leland Park—and Los Angeles Recreation and Park Department, in general—needs is a rich fairy godmother.




WHAT WE DO... WHAT WE'VE DONE... WHAT WE ARE DOING:

- We provide monthly face-to-face meetings with representatives of the LAPD, CD15, POLA, and other community and regional organizations. We bring speakers on topical issues to meet community stakeholders.
- We maintain representation and communication with important community organizations such as the Chamber of Commerce, the Downtown Property Owners Improvement District, and our downtown Arts, Culture and Entertainment District (ACE).
- We participate in and collaborate with the Harbor Alliance of Neighborhood Councils for common oversight of our mutual interests. We are working with the other neighborhood councils of the Harbor Area to build a neighborhood councilbased organization to replace the Port Community Advisory Committee disbanded by POLA in 2013.
- We produced community information forums on LAPD Community Relations (September 2013) and Homelessness (April 2014).
- We advocated for the construction of landscap-

- ing and a mixed use trail for the north side of Front Street abutting China Shipping. This was accepted by POLA and is currently nearing completion of the design phase with an estimated completion date in fall 2015.
- We advocated for landscaping improvements on the north side of Knoll Hill (south side of Front Street), including the southeast corner of Front Street and Pacific Avenue. This is proceeding in the design phase with the use of China Shipping Mitigation Funds.
- We continue to monitor progress and comment upon the Port's and the LA Waterfront Alliance's plans to redevelop Ports O'Call.
- Leland Park neighborhood to organize and form a Park Advisory Board to restore maintenance and services at Leland Park.
