All,

Here is the deconfliction for our CeSPNC Bylaws. This is what needs to be discussed at tonight's meeting:

Bylaws:

- Our Bylaws were officially ratified by the board, including a second reading, I believe in November of 2021. It took DONE almost an entire year to get back to us. I did not receive anything back from DONE (Gibson) until September 15th, 2022. Attached is what was sent back to us and is what currently stands as our official Bylaws - unless the board decides to take alternative action(s) today or in the future.

- Article V - Governing Board
 - Section 4: Terms and Term Limits
 - "The new board will be seated the first meeting in the fiscal year after the election/selection/affirmation."
- Article VI Officers
 - Section 3 : Selection of officers
 - "Officers shall be selected from among the seated board members regardless of training status."
- Article X Elections
 - Section 6 : Installation of elected Board Members
 - "Installation of elected Board Members will take place at the first meeting of the fiscal year following the election/selection/affirmation"

Note: The Bylaws amendment which was proposed November 2022 did not pass by vote of the board:

- 1. Prior to a Censure the Board may with a majority vote admonish any Board Officer for conduct unbecoming of their position or for direct violation(s) of the Bylaws and Standing Rules
